THIS ACTION is at issue and is ready to be set for trial. Therefore, it is

ADJUDGED that:

1. This action is set for Non-Jury Trial on the undersigned judge's trial docket on Wednesday, February 28, 2018, commencing at 1:00pm, in Room 416, Alachua Family/Civil Justice Center, 201 E University Avenue, Gainesville, Florida, or as soon thereafter as counsel can be heard. The time allotted for the Non-Jury Trial is **one half day**. Parties and counsel are hereby directed to appear before the undersigned judge for the commencement of trial at **1:00pm on Wednesday, February 28, 2018**, unless otherwise notified.
2. **ALL DISCOVERY PROCEDURES ALLOWED BY THE RULES OF CIVIL PROCEDURE SHALL BE COMPLETED NOT LATER THAN 10 DAYS PRIOR TO THE NON-JURY TRIAL AS WELL AS THE TAKING OF ALL DEPOSITIONS FOR USE AT TRIAL.**
3. Not later than ten (10) days before Non-Jury Trial, the parties shall file and serve exhibit lists and shall meet personally and exhibit to each other all documentary and tangible evidence intended to be offered at trial and make a good faith effort to stipulate to their admissibility.
4. When appropriate, the parties are encouraged to file memoranda of law before trial and serve copies on all parties and the trial judge.

5. The purpose of this Order is to facilitate a fair and speedy trial in this action. Counsel shall communicate with each other in a timely manner and otherwise respond in good faith to this Pretrial Order.

6. All motions must be filed and heard prior to Non-Jury Trial.
