These topics will be identified each time by the Foreign Press Association and Bayer, as the major supporter of these initiatives.

Thanos Dimadis: the person from the Executive Director's role who will execute these initiatives by reassuring that Bayer as the Major Supporter will be actively informed and involved in the supervision of these planned initiatives.

1. Bayer's executive will present the first Scholarship Award of the night during the Centennial Year Gala Night. The Scholarship will be named as Bayer Foreign Press Scholarship. Bayer's executive will be able to give a 5 minutes speech given that Ray and Chris have been long-term supporters of the Foundation not only through their current roles at Bayer but from the previous companies they had served. Bayer's executives will be honorary guests of the Centennial Annual Gala Night. The Foreign Press Foundation will publicly acknowledge their constant support and contribution to the Foreign Press Foundation will publicly acknowledge their constant support and contribution to the Foreign Press Foundation.

2. Chris on behalf of Bayer joins the advisory board of the Foreign Press Foundation: he provides insights and support to the Foreign Press Foundation's objectives and plans. He participates in the FPF Board meetings. He is informed about the Foundation's plans, projects, and initiatives and he represents Bayer as a major past and future sponsor of the Foundation.

3. Bayer, as a major long-term sponsor of the Foreign Press Foundation, should be aware in advance about the honorees of the Foreign Press Awards and in general about any aspect of the Centennial Annual Gala night which is organized by the Foundation. The selection of the honorary awardees for the Foreign Press Awards should not be contradictory to Bayer's strategic communications plans and initiatives.

4. Thanos Dimadis will be the executive director of the Foreign Press Foundation and the Foreign Press Association for the period that Bayer is supporting the Foundation in 2018 and the years ahead. If for any reason Thanos Dimadis quits from my role as Executive Director of the Foreign Press Association or Foundation. Bayer's commitments and financial support to the Foundation are recalled, and Bayer is withdrawn as a primary sponsor of the Foundation. Bayer's collaboration to implement these strategic plans will be only with the Executive Director and any communication between the Foreign Press Foundation, and the Foreign Press Association will be through either the Executive Director, Thanos Dimadis or the Chair of the Board of Governors, Nancy Kamel.

c. Concernence of Bayer's sponsorships. Part of these initiatives will begin being implemented and executed in the last quarter of 2018 and 2019. The goal is that these initiatives will become permanent in the years ahead beginning from this year, 2018.

For the years 2019 and 2020 Bayer makes a commitment of the same level donation (\$25,000) as previous years to the Foreign Press Foundation under the provision that the Foreign Press Foundation and n Press Association agree to implement with Bayer the following initiatives:

1. Organizing two forum discussions per year (one in the Spring and one in the Fall) starting with the first one in Fall 2018 (the next ones will be in Spring 2019 and Fall 2019). These will be all-day forum discussions in collaboration with the Schools of Journalism in New York (for those students of journalism who will attend they will be granted with a Certificate of Attendance). These forum discussions will be attended by exclusive members of the international and American press, bloggers, and online media influencers. These all-day forum discussions will consist of prominent speakers, and experts from the specific topics agreed between Bayer's executives and FPA. These are going to be topics relevant to Bayer's strategic communications goals and priority (for example agriculture, or any other issue that matter to Bayer). These topics will be developed in a way to attract attention from the media representatives by identifying and inviting media influencers. The Foreign Press Association will be the vehicle for organizing this initiative. Bayer will be the principal sponsor in regards to the executive source of the back of the back of the day of the advective director. 3. Each year there will be two main cocktail parties for foreign and American journalists starting in December 2018 (the next one in June 2019 and another one in December 2019). Bayer and Thanos work together on identifying the media influencers from the American and international community of journalists in New York, and speakers-media influencers who will attend and engage with Bayer's executives and the mission of the Foreign Press Association.

4. Each year there will be three background briefings with Bayer's executives and selected members of the international and national press and online bloggers- organized by the Foreign Press Association to inform media representatives on topics that fit in Bayer's communications priorities and strategic goals.

5. The Executive Director on behalf of the FPA will work with Bayer's team to develop a certificate program on American politics and diplomacy (the first option will be this program to be developed in collaboration with the media department of the George Washington University). It will have the character of an executive education program. The Executive Director on behalf of the FPA will bring together stakeholders, such as State Department, United Nations, to enrich this one week program with exclusive takes and seminars, by giving these young jinternational journalists the opportunity to become affiliated with the American political and media culture in Washington DC. The work for the execution of this program starts on July 1st, and the goal is the first enrollment of 10 international journalists to begin in Fall 2019.

6. The Executive Director works with Bayer's executives during each year to provide them with any support they may need in arranging media contacts and meetings in national and international level.

Thanos Dimadis, the person who executes these initiatives along with Bayer, will develop and agree with Ray and Chris a parallel framework of an agreement that contains the execution costs of implementation (hours of work/ timeline/ reports of progress).
