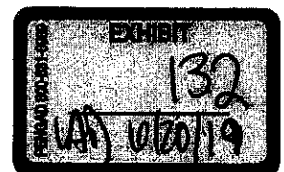

- Agreement on maintaining nontarget plant (NTP) studies as is. No new studies to be conducted.
- Include additional samplers further out in the field in the Drift Reduction Technology (DRT) Field Study.
- Evaluate the impact of various adjuvants (types) in DRT wind tunnel study to determine effect on spray distribution.
- Agreement to utilize the DRT Protocol as a means of determining the baseline buffer requirements for Clarity and Engenia.
- Utilize field bioassay data to determine commercially acceptable buffers.
- Step-wise approach with EPA regarding buffer determination: NTP comparability, Field DRT, Wind Tunnel DRT, and field bioassay studies for safety.
- Collaborative approach between the two companies with one message to EPA.
