Ty, wanted to follow up on the Frey Farms report on Dicamba at their Kennett farm in the bootheel. We are going to have them into StL the morning of Sept 14th and would like to have a follow up to their concerns and issues they experienced.

Kristin, to get you up to speed. Frey Farms is a strategic account for our Seminis team. They are the largest buyer of our watermelon seed in the entire US and are 100% onboard with our Corn program. Their watermelon, Liberty soybeans and sweet corn were hit pretty hard by dicamba use in the bootheel. I would like to work with your team to consider acquire marketing opportunities to transition them to our program and also look into hosting a xtend program training session for growers and applicators around the Kennett area.
