My comments for the following points:

Off-target Crop Injury Tracking – Both companies will investigate off-target injury claims. The details of these incidents will be recorded in company specific databases:

RMC Comment – Monsanto will respond to off-site movement, but it is the responsibility of the applicator to evaluate the environmental conditions and determine if it is safe to apply. Out proposed label will include warnings that the applicator should not apply if there is a risk of movement to a sensitive crop. Off-site movement due to drift will afford the companies to reinforce application requirements and proper stewardship, but may not be tracked as incidents in specific databases. Other off-site movement will be investigated and tracked.

If grower follows label restrictions and there is still claim for off-target crop injury, how will it be handled by BASF and Monsanto? The incident will be investigated consistent with current BASF and Monsanto company processes

RMC Comment – The application requirements do not guarantee that there will not be drift, they just give the applicator the best chance of not encountering drift. Inquiries about off-site movement will still be focused on following requirements, but also on proximity of sensitive crops and the applicator restriction from application if there is a risk of drift to that crop. Further investigations will follow standard procedures.
