In the meantime I wanted to make you are aware that this morning Stew sent a copy of a presentation that Stanley Culpepper and Larry Steckel gave at Beltwide. The following statement appears on one of the slides: *"INJURY and EPA MAY BE THE DRIVER; VERY POSSIBLE EPA COULD PROHIBIT TANK MIXES"* and remaining slides go into significant information about volatility/drift/injury.
