I let her know that Professor Heylings had communicated with us that he had spoken with her and I was inquiring to see if EPA needed any information from Syngenta. She indicated nothing was needed at this time. She did indicate that his email communications and any other documents he may choose to provide would be posted to the docket as public comments. Marianne indicated the draft risk assessments had been completed but not yet posted as the Federal Register Notice is under preparation. These should post soon, maybe by end of August.
