Tom/Brad –

In anticipation of the forecasted rainfall and in light of existing restrictions on AltEn's water movement, I would like to make a request allowing for the judicious transfer of water (above ground) between the plant sumps, the emergency lagoon and/or bermed areas and the industrial lagoons on an 'as needed' basis. The purpose would be to maintain reasonable freeboard in the former features to allow for continued treatment operations. It is our expectation that this special request would apply through Monday 5/17 in order to provide sufficient time to complete any necessary transfers; particularly those related to any water retained in the bermed areas.
