Hello everyone,

I am writing to see if everyone would be available at some point on Thursday to talk about the Neonicotinoid

Bill. The hearing is on 2/17 at 1PM in EHEA. As of now, there is no crossfile of the bill.

As I understand it, the bill will do the following:

-Require that all products containing neonic pesticides (which are defined as the following: IMIDACLOPRID; NITHIAZINE; ACETAMIPRID; CLOTHIANIDIN; DINOTEFURAN; THIACLOPRID; THIAMETHOXAM; OR any other chemical designated by the Department as belonging to the neonicotinoid class of chemicals) and seed, plant material, nursery stock, annual plant or bedding plant treated with these pesticides to bare the following label in order to be sold in the state:

"WARNING: Bees are essential to many agricultural crops. This product has been treated with neonicotinoid pesticides, found to be a major contributor to bee deaths and the depletion of the bee population."

- After January 1, 2016, a retailer may not sell a neonicotinoid pesticide unless they sell controlled use pesticide.
- After January 1, 2016 a person cannot use a neonicotinoid pesticide unless they are a certified pesticide applicator, a farmer using the pesticide for agricultural purposes, or a veterinarian.
