Your manuscript entitled "A Zika virus envelope mutation preceding the 2015 epidemic enhances virulence and fitness for transmission" has now been seen by 3 referees, whose comments are attached below. In the light of their advice we have decided that we cannot offer to publish your manuscript in Nature.

While the referees find your work of some interest, two of the referees raise concerns about the strength of the novel conclusions that can be drawn at this stage, particularly with regard to being able to link this mutation to establishment of the 2015 epidemic. We feel that these reservations are sufficiently important as to preclude publication of this study in Nature.

I am sorry that we cannot be more positive on this occasion. We hope that our decision does not discourage you from submitting your work to us in future as we remain interested in publishing key developments in this area of research.
