New Practice Competencies Initiative

The CDR Competency Assurance Panel collaborated with the Academy's Quality Management Committee on the development of dietetics practice competencies and performance indicators. These competencies and performance indicators will replace the current learning need codes for

the Professional Development Portfolio recertification system in 2015 beginning with new registrants whose registration begins on or after June 2nd, 2015 and current registrants beginning their June 1, 2016 recertification cycle. An article describing the development and validation of the practice competencies was published in the June 2015 *Journal of the Academy of Nutrition and Dietetics*.

The CDR website has been updated to include a Practice Competencies page, <https://www.cdrnet.org/competencies>, which includes several practitioner resources including recordings of webinar presentations made during 2015–2016.
