Subject: WHO Code of Conduct Pathogen Genetic Sequence Data During Outbreaks - For Comment by Jan 23

Dear Colleagues,

WHO has released for comment its draft code of conduct for open and timely sharing of pathogen genetic sequence data during outbreaks of infectious disease (attached). WHO developed this under the umbrella of the R&D Blueprint and its data and sample sharing work, drawing from experiences during previous outbreaks where sharing of pathogen GSD has been delayed, thereby slowing outbreak and R&D responses. It also comes as WHO is in the process of a broader evaluation of its approach to data and sample sharing, and access and benefit sharing (ABS) as cross-cutting issues. We have been encouraging WHO to take leadership in assessing and explaining the public health impacts of sample sharing and ABS, particularly the public health impacts of the Nagoya protocol, in alignment with our position that issues pertaining to public health should be determined by health experts.

Per WHO:

"Pathogen genetic sequence data (GSD) is an increasingly valuable source of information in understanding and controlling outbreaks of infectious disease. With the advent of next generation sequencing, the depth/extent of available information will expand further. A key concern in recent outbreaks has been variable timelines between the start of an outbreak and the public availability of the first and subsequent genetic sequences. WHO strongly supports public access to sequence data to inform public health and research decision-making during outbreaks, the equitable sharing of benefits derived from the use of such data, and the legitimate interests of data providers. WHO has consulted with many stakeholders and institutions working in the pathogen sequencing arena, including those who have been involved in applications to recent outbreaks. Based on these consultations, and on lessons learned from recent outbreaks as part of the data sharing workstream of the WHO R&D Blueprint, WHO is proposing elements of a code of conduct for GSD sharing in infectious disease outbreaks.

Through this code of conduct WHO seeks to contribute towards an enabling environment for sharing of pathogen GSD where equitable benefit sharing and the needs of data providers around the world can be addressed so that rapid international sharing of sequence data can occur consistently, in accord with IHR 2005, allowing public health authorities, product developers and researchers to collaborate more effectively from a position of mutual trust with respect for submitters' rights to the information they provide."

WHO is asking for stakeholders to provide comments via the attached comment form by January 28. I would be happy to consolidate USG comments and send them all together in a single compiled document if you please send me your comments by COB Wednesday, January 23, 2019.

If there are strong concerns around the document, we can organize a call in coordination with the leads of the USG Sample Sharing Working Group and our colleagues at State IHB to discuss our approach to providing feedback, perhaps considering drafting a summary document outlining our concerns as Ruvani suggested last week as opposed to simply providing comments via the comment form.

Dear Colleagues,

WHO has released for comment its draft code of conduct for open and timely sharing of pathogen genetic sequence data during outbreaks of infectious disease (attached). WHO developed this under the umbrella of the R&D Blueprint and its data and sample sharing work, drawing from experiences during previous outbreaks where sharing of pathogen GSD has been delayed, thereby slowing outbreak and R&D responses. It also comes as WHO is in the process of a broader evaluation of its approach to data and sample sharing, and access and benefit sharing (ABS) as cross-cutting issues. We have been encouraging WHO to take leadership in assessing and explaining the public health impacts of sample sharing

and ABS, particularly the public health impacts of the Nagoya protocol, in alignment with our position that issues pertaining to public health should be determined by health experts.

Per WHO:

"Pathogen genetic sequence data (GSD) is an increasingly valuable source of information in understanding and controlling outbreaks of infectious disease. With the advent of next generation sequencing, the depth/extent of available information will expand further. A key concern in recent outbreaks has been variable timelines between the start of an outbreak and the public availability of the first and subsequent genetic sequences. WHO strongly supports public access to sequence data to inform public health and research decision-making during outbreaks, the equitable sharing of benefits derived from the use of such data, and the legitimate interests of data providers. WHO has consulted with many stakeholders and institutions working in the pathogen sequencing arena, including those who have been involved in applications to recent outbreaks. Based on these consultations, and on lessons learned from recent outbreaks as part of the data sharing workstream of the WHO R&D Blueprint, WHO is proposing elements of a code of conduct for GSD sharing in infectious disease outbreaks.

Through this code of conduct WHO seeks to contribute towards an enabling environment for sharing of pathogen GSD where equitable benefit sharing and the needs of data providers around the world can be addressed so that rapid international sharing of sequence data can occur consistently, in accord with IHR 2005, allowing public health authorities, product developers and researchers to collaborate more effectively from a position of mutual trust with respect for submitters' rights to the information they provide."

WHO is asking for stakeholders to provide comments via the attached comment form by January 28. I would be happy to consolidate USG comments and send them all together in a single compiled document if you please send me your comments by COB Wednesday, January 23, 2019.

If there are strong concerns around the document, we can organize a call in coordination with the leads of the USG Sample Sharing Working Group and our colleagues at State IHB to discuss our approach to providing feedback, perhaps considering drafting a summary document outlining our concerns as Ruvani suggested last week as opposed to simply providing comments via the comment form.

Dear Colleagues,

WHO has released for comment its draft code of conduct for open and timely sharing of pathogen genetic sequence data during outbreaks of infectious disease (attached). WHO developed this under the umbrella of the R&D Blueprint and its data and sample sharing work, drawing from experiences during previous outbreaks where sharing of pathogen GSD has been delayed, thereby slowing outbreak and R&D responses. It also comes as WHO is in the process of a broader evaluation of its approach to data and sample sharing, and access and benefit sharing (ABS) as cross-cutting issues. We have been encouraging WHO to take leadership in assessing and explaining the public health impacts of sample sharing

and ABS, particularly the public health impacts of the Nagoya protocol, in alignment with our position that issues pertaining to public health should be determined by health experts.

Per WHO:

"Pathogen genetic sequence data (GSD) is an increasingly valuable source of information in understanding and controlling outbreaks of infectious disease. With the advent of next generation sequencing, the depth/extent of available information will expand further. A key concern in recent outbreaks has been variable timelines between the start of an outbreak and the public availability of the first and subsequent genetic sequences. WHO strongly supports public access to sequence data to inform public health and research decision-making during outbreaks, the equitable sharing of benefits derived from the use of such data, and the legitimate interests of data providers. WHO has consulted with many stakeholders and institutions working in the pathogen sequencing arena, including those who have been involved in applications to recent outbreaks. Based on these consultations, and on lessons learned from recent outbreaks as part of the data sharing workstream of the WHO R&D Blueprint, WHO is proposing elements of a code of conduct for GSD sharing in infectious disease outbreaks.

Through this code of conduct WHO seeks to contribute towards an enabling environment for sharing of pathogen GSD where equitable benefit sharing and the needs of data providers around the world can be addressed so that rapid international sharing of sequence data can occur consistently, in accord with IHR 2005, allowing public health authorities, product developers and researchers to collaborate more effectively from a position of mutual trust with respect for submitters' rights to the information they provide."

WHO is asking for stakeholders to provide comments via the attached comment form by January 28. I would be happy to consolidate USG comments and send them all together in a single compiled document if you please send me your comments by COB Wednesday, January 23, 2019.

If there are strong concerns around the document, we can organize a call in coordination with the leads of the USG Sample Sharing Working Group and our colleagues at State IHB to discuss our approach to providing feedback, perhaps considering drafting a summary document outlining our concerns as Ruvani suggested last week as opposed to simply providing comments via the comment form.


