Yong - this corresponds with a series of recent Reducted-like publications coming out of Germany and with some potentially troublesome postings about Monsanto and Eugenics (see other e-mail I forwarded to you)

Donna Farmer and I have been ringing alarm bells and pushing for this kind of broad solution for a decade, and we have been following the development closely, including conversations about how to update/adapt Monsanto web content and information (the MOST RECENT glyphosate posting on general safety was last updated in 2002!) as well as discussing new content development for responsive websites both in EU and in US/Canada.

I proposed a second paper from Felsot (who wrote the recent article for ACSH on pesticide safety with a lot of glyphosate examples) specifically on glyphosate- but the feeling was that we wanted to avoid US experts on the EU site. This is being assessed for a US version of the site via Bill.

We are certainly aware of and prepared to support this effort. The new publication series on Glyphosate (Williams 2012/repro, Mink 2012 /non-cancer epi, Mandel – pending- cancer outcomes, etc.) is designed to support this effort among other purposes.

As far as getting it started sooner- this has been a difficult multi-company "cat-herding" operation- but if there is a perception of urgency among the major stakeholder companies- we can certainly support accelerated development. The web contractor/developer has been selected (in Germany- with this issue and Rapporteur status in mind) – but I have not yet seen a proposed process for materials development.

I will loop back with Bill to see how we can best support progress on this initiative and facilitate acceleration in any way that I can out of RPSA.

Please find attached a memo on the current anti-Glyphosate campaign in Germany. In our analysis we come to the conclusion that the campaign does not solely aim at discrediting Glyphosate. We strongly believe that the strategic aim of this campaign is much broader:

- In attacking the current way in which regulators base their risk assessment on sound science the good
 reputation of authorities responsible for the risk assessment and risk management (such as BVL or BfR in
 Germany or EFSA at European level) should be damaged to open up the doors for a more "political" and "NGOminded" approach of evaluating crop protection products.
- At its heart the campaign aims at attacking the cultivation of GMOs outside Europe, particularly in Latin America. As a result of the scaremongering, consumers and stakeholders of the food value chain should come to the conclusion to refrain from GMO food/feed or goods that have been produced by using of GMO feedstuff.
